1977 LEGISLATURE TAKES AN INCOMPLETE

State lawmakers adjourned on schedule June 3 but without performing the one essential task required of them — adoption of an appropriations bill and passage of tax legislation to fund it.

Recalled into special session June 8, the outcome of their deliberations was uncertain at UPDATE press time.

A number of bills were taken up which have special interest for the university community. The so-called "Deep Throat" bill was passed; it requires that each campus establish a committee to screen films to be used in classes for conformity to community standards.

Bills that failed to pass include special funding for women's athletics, tuition-free credit courses for senior citizens; tuition waivers for children of law enforcement personnel killed in the line of duty; and a proposed requirement that the Legislature reappropriate Federal grants. The bill that would have authorized longevity pay also was not passed.

Among the measures strongly backed by the State University System that passed are: permission for agency heads (university presidents) to approve membership dues without prior Department of Administration approval; authorization for the electronic transfer of wages and salaries to banking institutions (subject to implementation by the State Comptroller); permission for the exchange of SUS personnel with personnel in industry without a break in state benefits; facilitation of early retirement of state employees; and authorization for state universities to accept credit cards in transacting business with students.

Some of these measures were still awaiting the governor's signature. In all cases, information may still be incomplete and official notice has not yet been received. Additional information will be provided on these and other measures as fast as the smoke clears.

NAMING OF FAU BUILDING ON REGENTS' AGENDA

At press time (June 11), the Board of Regents, meeting in Tampa on June 13, was to act upon a recommendation of the Facilities Committee that the General Classroom Building North on the FAU campus be named for the late Thomas F. Fleming, Jr.

Fleming, who died March 15, 1976, was a key figure in efforts to establish FAU and in negotiations for obtaining land from the federal government for the university. In 1963 he served as chairman of Citizens for Florida's Future, the lay group formed to obtain voter approval for the first constitutional amendment permitting bond financing for construction of university, community college and vocational school buildings. Fleming served as the first and only chairman of the board of the FAU Foundation from its inception, prior to the establishment of the university, until his death.

The Stanton D. Sanson Science Building on the campus is named for the man who headed the finance committee for the bond drive and who was an outspoken advocate of education. He was a transplanted New Yorker and a self-educated man and predicted that the growth and economic well-being of the State of Florida was dependent upon its ability to provide a quality educational program at all levels. He died Dec. 21, 1964, shortly after the bond campaign was won. Dedication of that building was held Dec. 18, 1965.

The only other building on the FAU campus to be officially named and dedicated is the S. E. Wimberly Library named in memory of FAU's vice president for academic affairs and dedicated on Nov. 1, 1974.

She is serving as consultant to the Nova Research and Development Center (Broward County Public Schools) in the development of a competency-based staff development model applicable to the National Teacher Education Center concept.

DR. WILLY FEUERLEIN (chmn, Econ) returned from a two - week trip to Frankfurt and other European cities, conducting research in international economics. While in Aachen, he presented a public lecture at Technical University on "Newer Aspects of American Economic Policy Toward Less Developed Countries."

ALYCE ESSI (sec, Univ Atty) was elected president of the newly formed Broward County Chapter of the St. Jude Children's Research Hospital, founded by comedian Danny Thomas.

DR. JOHN E. MIKLOS (prof, Admin/Sys) was recently appointed to the Boca Raton Social Security Study Committee and was elected chairman of the committee.

DR. JOEL E. ROSS (prof, Mgmt) recently published his eighth book while at FAU — *Managing Productivity*.

DR. PAGE TALLEY (prof, Ed) recently conducted two workshops on counseling techniques for Planned Parenthood. He has been named to the Advisory Board of the local chapter.

BILL POLLIER (assoc dir, Found) recently spoke to the Ft. Lauderdale Rotary on the free enterprise system and to the Ft. Lauderdale Kiwanis on government regulations.

ADELAIDE SNYDER (dir, UR) spoke to the Palm Beach Rotary at the Breakers last week and is scheduled for the West Palm Beach Rotary this month - on an FAU update and new trends in higher education.

BILL McCRAY (couns, Adm) recently attended the Florida Black Student Association District Coordinators Meeting held at the University of South Florida at Tampa. He also visited the three campuses of Hillsboro Community College, in conjunction with the SUS team visitation plan.

DR. CREECH, DR. MICHELS ATTEND COMMISSION MEETING

President GLENWOOD L. CREECH and Vice President for Academic Affairs KENNETH MICHELS were among the panelists at a two-day meeting of the Commission on the Future of Florida's Public Universities at Florida International University, Miami, June 7 and 8.

Dr. Creech was the host for the luncheon session on June 8 when he and Dr. Michels, along with FIU President HAROLD B. CROSBY and FIU's Vice President for Administrative Affairs RON ARROWSMITH discussed the upper division university in Florida. Dr. Creech emphasized that place-bound and job-bound adults must have access to higher education and lifelong continuing educational opportunities and that the upper division university in urban centers with branch campuses filled this need.

Dr. Michaels said that quality was readily maintained in the upper division university and pointed out the accreditation record each of Florida's universities had with the Southern Association, as well as FAU's success with its College of Business and Public Administration, two departments in the College of Engineering and the College of Education, each of which had been recognized by the appropriate national body in record time.

Arrowsmith discussed the funding problems of upper division urban schools, noting that a high proportion of the student body attends part time. Since funding is based on FTEs, this imposes a financial hardship, since it takes three students to create one FTE. He pointed out that those three people represent three registrations, three individuals to be counseled, three persons to be provided space and facilities, and so forth. Dr. Crosby outlined the history of the upper division university movement, noting that the first successful ones were established in Florida.

ACCOUNTING COURSE USES BOCA HOSPITAL AS MODEL

A graduate accounting course to be conducted during the upcoming summer term by DR. EDWIN A. WOOD will use the Boca Community Hospital as a model for testing cost accounting theories. Students will spend time at the hospital observing the application of subject matter to hospital costs.

The course, Accounting 640, is worth 5 credit hours and is part of the MBA with an accounting concentration. Contact Dr. Wood or the Department of Accounting, College of Business for more information on the course.

YEAR-LONG GRANTS AWARDED TO THREE

Dr. Vincent Named Professor at Air University

DR. JACK E. VINCENT (prof, Pol Sci) has been named professor of National Security Affairs and will serve as program and curriculum consultant at Air University, an Air Force officers training school at Maxwell Air Force Base, Montgomery Alabama.

Dr. Vincent has been assigned by FAU to Air University through June, 1978 as part of a Federal inter-governmental exchange program. The assignment has been made possible through a grant from the Air Force.

Dr. Nicholas' Research Aids Dade Legislators

Since April, DR. JAMES C. NICHOLAS (assoc prof, Econ) has been working in an "auxiliary staff capacity" for the Dade County Legislative Delegation, researching topics of particular importance to the Dade legislators.

The delegation has granted Dr. Nicholas \$5,000 for research he is conducting, as the need arises, through April, 1978. At UPDATE press time, the delegation was expected to meet in Tallahassee to "nail down" the agenda for the remainder of Dr. Nicholas' contract. Constitutional revision and election reform are expected to be among the issues on which the Dade legislators will require research. Dr. Nicholas said that the possibility exists that the Broward and Palm Beach County legislators will develop a similar research program.

Dr. Baker Awarded NSF Grant

DR. EARL W. BAKER (Dean, Sci) has been awarded a one-year, \$52,000 National Science Foundation grant to study sediment cores recovered by deep sea drilling, through June, 1978.

DR. SUSAN L. PALMER (res assoc) will assist Dr. Baker in his study of chlorophyll-containing marine organisms. One practical application of the research is the analysis of the sediment to determine the possibilities of oil, coal and natural gas as end products of the decaying process.

NO CHANGE IN FEES NEXT YEAR

The Legislature failed to take any action on fees during the regular session. It is unlikely that the limited special session will get into the student fee issue. Accordingly, the registration and tuition fees in effect in the State University System during 1976-77 will continue during 1977-78, without change.

ALUMNI CRUISE PLANNED

The Florida Atlantic University Alumni Association will host a three-day cruise departing from Miami for Nassau on Sept. 9. The cruise, on the Sunward II, will include tours, a beach party at Chub Cay, and other special activities for FAU graduates and their guests. TRAVEL ADVANCES AVAILABLE FOR FACULTY, STAFF

CAMPUS NOW HAS FINAL AUTHORITY FOR PARKING FEES

With the passage by the 1977 Legislature of SB 235, final disposition of parking violations is now in the hands of campus authorities.

Over the course of the past year at FAU, over 4,000 parking tickets have gone unpaid. The vast majority are given to transients on the campus. Because of the inability of the off-campus courts to take notice of these violations or to do anything about them, both the scholarship fund and traffic and parking improvement fund are "out" some \$10,000 to \$15,000.

New procedures for enforcement of parking regulations and fines are currently being developed for implementation October 1, the effective day of the legislation.

"STUDENT REGENT" BILL PASSED

HB 2050 placing a non-voting student on the Board of Regents and expanding the number of Regents to 10 passed the Legislature on the last day of the 1977 regular session. It was a compromise measure and was approved by a wide margin, minutes before the body adjourned.
