It was a pleasure to talk with you about the plans for a new university in Florida, and I am glad that you have agreed to serve on the Advisory Committee. Other members of the Committee will be John E. Ivey, Jr., Meredith Wilson, Ray Carpenter, Howard Phillips, Gordon Blackwell, and Doak Campbell.

A tentative plan for a state university at Boca Raton has been prepared by Dr. John E. Ivey, Jr., for the Board of Control of Florida. The plan embodies forward-looking ideas designed to provide an educational program of outstanding quality within the financial resources of the State.

The plan as presented in the accompanying document has been approved by the Board of Control with the understanding that before the program is put into effect further refinements and revisions may be required.

The Advisory Committee, therefore, is asked to review the plan and to address itself to the general question, in what respects, if any, should this plan be revised to improve its promise of success? More specifically, what practical problems should be anticipated and how can these problems be solved?

It is urgent that the Advisory Committee complete its assignment at an early date because requests for funds for developing the plant and employing the initial personnel of the new university must be presented to the next session of the Florida Legislature, which will convene on April 4, 1961.

As I mentioned to you in our telephone conversation, the Advisory Committee will meet for two days on the 16th and 17th of June and again for two days during the week of July 18.

The Planning Commission will pay expenses incurred in attending the meetings and an honorarium of \$150.00 per day for the days spent in the conferences. We do not anticipate that you will be asked to give any appreciable amount of time to this project in addition to the committee meetings, although you may be asked to give a brief statement of your opinions or suggestions as plans develop.

We will make a reservation for you at the Duval Hotel; however, should you prefer to make your own arrangements, please advise us to that effect.

To assist the members of the Advisory Committee in making flight arrangements, we have prepared the enclosed schedule of airline arrivals and departures for Tallahassee from and to New Orleans, Atlanta, and Jacksonville. Also enclosed is Form No. C-677, State of Florida Request for Transportation, in duplicate, which will cover the cost of a round-trip ticket to Tallahassee when presented at an airline ticket agency. When your ticket is issued, the transportation request form will be completed by the issuing office. The ticket agency will retain the original (printed on blue paper) and return to you the duplicate (printed on pink paper). It will be necessary for you to bring the duplicate with you to Tallahassee for accounting purposes.

I mentioned to you the matter of acoustic partitions. One of the companies which I referred to is the Koppers Company, Incorporporated, Metal Products Division, Scott and McHenry Streets, P. O. Box 298, Baltimore 3, Maryland. Koppers Company makes a "silent wall" which is an automatically operated series of steel panels which are completely soundproof. It is expected to sell somewhere between \$20-\$24 per square foot installed.

The other company is Mahasco Industries, which is producing an acoustic drape designed by Dave Chapman, Assoc., 420 North Michigan, Chicago, Illinois. The drape is made on carpet looms with heavy metal fibers woven into the product. It has the appearance of carpeting and muffles sound to the same extent as a block wall. There have been no pricing policies established, but the indication would seem to be \$6-\$12 a square foot installed.

The products are presently being tested, and both companies should be announcing the product specifications and final costs sometime in the spring.
